- The Government of Nepal [GoN] has allocated funds towards the cost of Construction of Health Post Building and intends to apply part of the funds to cover eligible payments under the Contract for *Construction of Health Post Building at Kanchan-2, Gajedi (KRM/WORK/12/076/77)*. Bidding is open to all eligible as per Section III of bidding document.
- Kanchan Rural Municipality invites sealed bids or electronic bids from eligible bidders for the construction of Construction of Health Post Building at Kanchan-2, Gajedi under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 2,00,00,000.00
- Minimum Work experience of similar size and nature:
 - RCC Works: 245 M3
 - Rebar Works: 31 MT
 - Brick Works: 215 M3
 - Formwork: 1200 M2
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

- 7. Electronic bids must be submitted to the office *Kanchan Rural Municipality*, *Rupandehi* through PPMO's e-GP system <u>www.bolpatra.gov.np/egp</u> before 12:00 Noon on 2076/11/22 (5-Mar-2020). Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2076/11/22 (5-Mar-2020) at the office of Kanchan Rural Municipality, Rupandehi. Bids must be valid for a period of 90 (Ninety) days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs. 6,50,000.00 which shall be valid for 30 days beyond the validity period of the bid.
